

GDP vs excess death rate: a first look on the effects of the COVID pandemic

Abstract

We provide graphical evidence showing how the COVID-19 pandemic affected the economy and death rates of 47 countries. It is not possible to read the names of all countries in the submitted graph but the online version available at https://rizbicki.shinyapps.io/gdp_covid/ displays the countries names when hovering the cursor over the points of the graph.

Our goal is to provide, by means of the following graph, a preliminary perspective of how well 47 countries¹ coped with the challenges of the COVID-19 pandemic, in particular those on the economy and the health system. The graph shows that, in general, countries which suffered most severely on the economic side are those which presented the highest excess death rates in 2020.

The vertical axis displays the excess death rate of 2020, i. e. the number of deaths from all causes occurred in each country in 2020 divided by the expected number of deaths for the same year, estimated from the recent historical average² of deaths in the same country. The horizontal axis represents the percent change of the (real) gross domestic product (GDP) of 2020 for each country, when compared to the product of the previous year. Below we discuss some advantages and disadvantages of using such indices to measure the mentioned impacts and close with some remarks for possible future analysis.

The gross domestic product (GDP) is the monetary market value of all final goods³ and services produced by the economy of a country or region in a specific time period, often a year or quarter of year. It is widely used to measure the capacity of a country or region's economy to produce material wealth and welfare to its inhabitants.

³Final goods and services are used by consumers to satisfy their current needs. Goods and services used as inputs to produce other goods and services are defined as intermediate. The GDP considers only the value of final goods and services to avoid double (or multiple) counting the value of a given intermediate good used in the production of final goods or services.




Figure 1: 2020 GDP percent change vs Excess death rate for 47 countries

As any other measurement, it has deficiencies such as: it does not compute the impact of economic production on the environment, it does not consider how the wealth is distributed (inequality) and it does not consider elements that indicate the quality of life of the population (e.g. health status, education, social security, crime etc). Other indices were developed to quantify these effects, such as the green GDP (Stiglitz et. al, 2008), the Gini index (Gini, 1936) and the Human Development Index (United Nations, 1990), but the GDP has remained as a standard indicator to compare the economy of countries and regions, especially regarding their real (inflation discounted) growth rates, which indicate how fast the economy is increasing or decreasing its productive capacity.

The main reason for this is that virtually every country follows the same methodology to compute the GDP, a set of guidelines issued by the United Nations (United Nations, 2008) that has been discussed and improved since 1947, whereas statistics about the economic impact on the environment or income inequality may be collected differently across countries and are not readily available.

Similarly, one may use different indices to measure the impact of the pandemic on the population and/or the health system of a given country or region, but we believe the excess death rate has a straightforward meaning and may be readily computed once the national authorities provide the total number of deaths of the analysed period. Since it considers deaths by all causes, it prevents distortions such as under or over reports of the number of deaths caused by COVID-19.

It is also important to remember that, due to the social distancing measures adopted by several countries, deaths caused by other reasons (e.g. traffic accidents, crime, influenza, etc) almost surely decreased. On the other hand, it is plausible to assume that the number of deaths caused by diseases that require intensive care such as cancer, increased. Anyhow, both of these effects on the death rate will be exactly quantified only by future analysis of the disaggregated data of each country.

Therefore, we could use other indices to analyse the impact of the pandemic on the economy and on the health system of a country. To monitor the economy we could, for example, consider the unemployment rate (released monthly) and to monitor the health system we could follow the proportion of ICU beds occupied by COVID patients during the same period or the fatality rate per million of inhabitants. These indicators certainly provide an important picture to study the impacts of the pandemic but, as said before, the availability and methodology followed by each country add more provisos when comparisons are made between countries using such indicators. Thus, although we are aware of the limitations of using the GDP and the excess death⁴, we believe these numbers provide a good macro-view of the effects caused by the COVID-19 pandemic.

That being said, we remember some additional important points to read the graph. In general, the pandemic hit more heavily economies that are based on a few sectors such as the export of commodities or tourism. Often, economies with a more diverse structure are able to absorb great crises, but there are exceptions (e.g. the United Kingdom⁵). Another advice is to consider the recent past of each economy, since a 5% decrease in the GDP of a country whose economy was stagnated in the last three or four years does not have the same impact as a 5% decrease for an economy that grew 20% over the last five years.⁶

One should also bear in mind the political and geographical characteristics of each country when comparing how their policymakers reacted to the pandemic. Large countries such as Brazil and the US have a decentralized administration and, usually, regional governments have the autonomy to propose and implement restrictive measures, even though the federal administration has a major role in financing and providing inputs to the health system. A final remark regards the cultural environment of each country for this certainly influenced how closely the population followed the guidelines and restrictive measures imposed by the authorities which, in several countries, do not have the means to enforce them when the population does not follow the mentioned rules.

Final Remarks

In the future, more countries will release the 2020 GDP growth rate and the mortality data that will enable us to update the graph. An up to date version of the graph will be maintained at the website https://rizbicki.shinyapps.io/gdp_covid/. An exhaustive analysis of which policies were more effective to fight the pandemic and its economic effects would require much more space, but this will certainly be accomplished by the scientific community in the following years. Hopefully, this analysis will provide policymakers concrete guidelines to follow, respecting the circumstances and characteristics of each country.

Appendix: methodology and data for the excess death rate

The excess death rate of country i (EDR_i) was computed as:

$$EDR_i = \left(\frac{Deaths_{i,2020}}{Exp.Deaths_{i,2020}} - 1 \right) \times 100$$

where $Deaths_{i,2020}$ denote the number of deaths by all causes in country i in 2020 and $Exp.Deaths_{i,2020}$ the expected number of deaths for country i in 2020. This baseline number was estimated by Karlinsky and Kobak (2021) and is available at <https://github.com/dkobak/excess-mortality>. The dataset with the registered number of deaths for each country is available at <https://github.com/akarlinsky/world-mortality>.
